11. **Trade Policy development (TBT/SPS/Anti dumping etc.):** The Royal Government of Bhutan has banned the conduct of consumer trade fairs and general fairs that involve external parties and imported goods with effect from 23.12.2022. Only thematic fairs meant for promoting local goods and services and for export purposes will be allowed with prior approval from the Royal Government of Bhutan.

13. Development -

INTERNAL

1. 30th December 2022: Bhutan's economic growth rate as measured by its gross domestic product (GDP) is predicted to be 4.95 percent in 2022 and downgraded to 4.63 percent in 2023. The nation's economy is anticipated to expand more strongly the following year as the Indian economy expands more rapidly .

2. 720 MW Mangdechhu Hydroelectric Project was handed over to Druk Green Power Corporation (DGPC), Bhutan on 27th December 2022. Project has generated more than 9000 million units of energy since its commissioning, reducing 2.4 million tons of emissions annually, and earning Bhutan more than Rs. 12 billion in export revenue in 2021.

3. The Economic Affairs Ministry has banned the conduct of consumer trade fair and general fairs that involves external parties and imported goods i.e. w.e.f. 23.12.2022. Only thematic fairs meant for promoting local goods and services and for export purposes will be allowed. This is to balance the overall trade between the country's imports and exports.

4. Duty Free quota privileges will be withdrawn from 1st January, 2023 except for diplomats and international organizations governed by agreements. This is one initiative geared towards bringing in desired structural reforms.

5. 27th December 2022: With the re-opening of the economy, the total credit growth of financial institutions (FIs) saw an increase by 9.2 percent as of September this year from the same month last year, the Royal Monetary Authority figures show. Credit growth is good for an economy because FI's credit growth signals an economic recovery.

6. 21st December 2022: The 1,020 MW Punatsangchhu-II Hydropower Project Authority (PHPA) has reached an important milestone in the second stage of river diversion. The PHPA-II construction work is now approximately 93% complete. Ambassador Sudhakar Dallela, along with the Economic Affair's Minister Lokhnath Sharma, Bhutan, witnessed the second phase river conversion at the project site.

7. Ngultrum's value against the US dollar has fallen about 12% since January of this year, hitting an alltime high of Nu 84 per US dollar as of 20th December. This means we have to pay Nu 84 to buy USD.

8. The total import bill at Nu 93.03B as of September this year already surpassed one-year's import of Nu 90.23B in 2021. About 70 percent was imported from India. The prices of goods and services became costlier by 6.05 percent in September compared to the same month last year.

9. 21st December 2022: As of December 1, this year, the country's international reserve position was at USD 776.6mn with the Indian Rupee reserve in Royal Monetary Authority (RMA) forming Rs 6.3bn, and the convertible currency reserve USD 603.61mn. The rupee reserve was Rs 8.9bn as of December last year. The rupee reserves have been on a downward trend since April this year.

10. 20th December 2022: Cereal production has been in a downward spiral in the country. Farmers have placed more emphasis on vegetable production due to market availability and profits. Agriculture Ministry says this is due to a declining workforce in cereal cultivation. Farmers, on the other hand, are placing more emphasis in vegetable production.

11. 14th December 2022: According to Finance Minister of Bhutan, Bhutan's fiscal deficit will decrease from 11.01 percent of gross domestic product (GDP) to less than 5 percent by the end of fiscal year 2022-23. This means the budget deficit will fall below Nu 10.4 billion (B) from a budget deficit of Nu 22.89B in September this year.

12. The Ministry of Economy (MoEA) has launched Bhutan Trade Finnet (BTFN) System - Phase 1 - Import by wholesalers from countries other than India on 12th December 2022. This system facilitate cross-border trade and transaction by automating and integrating import licences and clearances. With the launch of this module, any wholesaler importing from a country other than India (COTI) can register as a system user in the BTFN system.

13. Bhutan's two official trade routes with India have been approved and are expected to be operational after the official launch next month. Government of India on 08 December notified that Kulkuli Land Customs Station (LCS) and Nagarkata LCS in West Bengal had been upgraded as a full-time LCS without any commodity restrictions.

14. Kholongchhu Project to be a fully DGPC owned subsidiary. Both India and Bhutan India reached an agreement that the Druk Green Power Corporation (DGPC) will take complete ownership of the project by buying back the shares of Satluj Jal Vidyut Nigam Ltd (SJVNL). Both DGPC and SJVNL will settle the transfer of shares by the end of December. To take the project forward, the GoI will provide support in terms of access to finance from India and market for power sale.

15. As of December 1, the reserve stood at USD 776.63 million (m) while the minimum requirements by central bank's threshold of USD 757M and will last for next 13 months to import essential goods. However, due to lower inflow of grants the net financial inflows which are used to finance the current account deficits is decreasing. This has impacted gross international reserves.

16. The Bangladesh government has considered the Bhutanese government's request to allow letters of credit in US dollars for orange imports from Bhutan. A letter of credit is a payment mechanism used in international trade that guarantees the buyer's payment from a creditworthy bank to the seller. The LC problem stems from the Bangladesh government's attempt to control its foreign exchange reserves by restricting certain imports.

17. The agriculture sector contributes very little to the country's GDP, according to the report 'Future of Bhutan's Workforce' released on 15 December by the Ministry of Labor, RGoB in collaboration with UNDP. However, the report suggests that digitization and the integration of technology into the agricultural sector can change this for the better.

BILATERAL

17th December 2022: Bhutan received an additional 50,000 doses of Pfizer's COVID-19 pediatric vaccine from the United States. This is the second shipment of the vaccine this year that the U.S. is providing to children in Bhutan. The vaccine is for children aged five to eleven and it was delivered in partnership with COVAX and the Bhutan Foundation.
