GDP: The Minister of Finance, Mario Marcel, stated before the Special Joint Commission of the National Congress that this year public finances will close with an effective surplus of 1.6% of the Gross Domestic Product (GDP), after almost a decade in negative territory.

Consumer Price Index (CPI): The National Statistics Institute released the CPI for September 2022. According to the figures, it registered a monthly increase of 0.9%. This figure means a respite for the pockets of Chilean men and women, as a percentage below 1% had not been seen since June. It can also be seen in general terms that inflation has been falling over the last three months.

World Bank: The institution projected that poverty in Chile will reach 10.5% by 2022 due to the end of state aid, in addition to the country's current economic situation with inflation and liquidity.

The International Monetary Fund (IMF): IMF projects that the Chilean economy will grow 2.1% this year and forecasts a drop of 1.3% in 2023. Despite this, the organization estimates that the country is experiencing a transition towards a more sustainable growth after the COVID-19 pandemic.
