IPSA: After the victory of the Rejection, the IPSA (Selective Stock Price Index), the main indicator of the Santiago Stock Exchange, rose significantly. In detail, a total of 4.63%.

Consumer Price Index (CPI): The National Institute of Statistics (INE) released the Consumer Price Index. August CPI rises 1.2% over the previous month and accumulates 9.9% increase so far this year. According to INE, the 12 divisions that make up the basket had positive impacts on the monthly variation. Food and non-alcoholic beverages (2.0%) and transportation (1.6%) stood out. Finally, the Unidad de Fomento -UF- will show

an increase of \$407 by the end of the month.

Chile's commercial exchange: Between January and August 2022, Chilean exports rose to US\$ 65,678 million, with a growth of 6.3% compared to the same period of 2021. As for imports, these amounted to US\$ 71,648 million, with an increase of 26%, in the same period, according to the report of the Undersecretariat of International Economic Relations (SUBREI).

Dollar: The Currency started the month with a fall and fluctuated between \$871.8 and \$878 at the opening. This is directly related to the strong rebound of around 4.7% recorded by copper this week as a result of the inflation data recorded by China, where they saw less accelerated increases. Mid September the dollar opened with a downward trend and settled below \$900 and by the end of the month the dollar opened higher and surpassed the \$965.

National Statistics Institute (INE): The INE published the national unemployment rate for the June-August mobile quarter. According to the figures, there was a drop in unemployment of 0.6 percentage points, reaching 7.9%. This is explained by the increase in the labor force (6.5%), which was lower than that of employed persons (7.2%).

Local Economy in decline: Both the Trade Activity Index (IAC) and the Industrial Production Index (IPI) decreased during August, thus showing signs of the economic slowdown. The former, according to the National Statistics Institute (INE), recorded a year-on-year decrease of 11.9% last month, affected by the contraction in the three divisions of which it is composed, accumulating a variation of 0.2% in the eighth month of the year.

Memorandum of understanding with Indian nut growers: In 2020 the Preferential Scope Agreement between India and Chile was to be updated, however the pandemic came and it was postponed. Since 2021, ChileNut has been working on initiatives to reduce the tariff. ChileNut held meetings with the Indian Ministry of Commerce and the Kashmir Producers' Association, with whom an agreement of intent was signed to provide formal support for the reduction of tariffs in exchange for technical transfer, including the construction of a model orchard in the Kashmir area. In return, the Kashmir Association will deliver a letter of support for the reduction of tariffs between Chile and India.
