In the current financial year, while demand for engineering goods, petroleum and textile remained strong, there has been some demand slow down in chemical and specialty chemicals, pharma and electronics. Mission has requested the concerned export promotion councils if any specific steps to be taken to expedite the export growth in these segments.

(ii) Qualitative Feedback

Market Access Alerts:

Mission has come across to several fraudulent activities by few Moroccan importers regarding export shipments from India in marble and ceramic sectors, who have either released the export documents fraudulently or have resorted to unethical trade practices. These documents were supposed to be released upon making payment to Indian exports i.e. 100% CAD. It is also suspected that it might be an act of a group of people who are working in cartel and have indulged in this unethical practice to commit fraud upon Indian exporters particularly marble exporters. In few cases, since the documents were not released by the importers, customs have resorted to auction the consignment resulting into heavy losses to the Indian companies and banking institutions.

Action taken by Embassy on Fraud Cases of Releasing Consignments:

The Mission sent the verbal note no 396/2022 to the Ministry of Foreign Affairs, African Cooperation and Moroccan Expatriates, informing about several fraudulent practices made by few Moroccan importers regarding export shipments from India in marble and ceramic sectors, and requesting to take urgent necessary actions to prevent recurrence of such incidents in future. It is also requested that the necessary action against these importers may kindly be taken including resolution of the complaints of the Indian exporters and payment of their dues.

Also, many Marble and ceramics' associations and federations was apprised about this issue. In addition, the Mission issued a suitable advisory in this matter to ensure business interests of Indian exporters.

Mission will keep continuing its efforts to pressurise the local importers to release funds to the Indian exporters and also raise awareness in the business circles both in India and Morocco so that healthy trade environment sustain.

Morocco and India Discuss Partnership Opportunities

Morocco's Minister of Energy Transition and Sustainable Development Leila Benali reviewed prospects of bilateral cooperation during a meeting with Secretary (CPV &OIA), Dr Ausaf Sayeed.

On November 24, Secretary (CPV& OIA) co-chaired the fifth India-Morocco Foreign Office consultation in Rabat where the two countries discussed discussed avenues to evolve the partnership between the two countries, seeking to expand it especially in the fields of green energy, electronics, biotechnology, and automotive manufacturing along with strengthening of bilateral trade. Both sides also discussed possibilities for cooperation in the cultural, academic, and university fields.

India Participates in UNWTO Conference in Marrakesh

Morocco hosted the 117th UN World Tourism Organization Executive Council meeting in Marrakesh in the month of November 2022 where UNWTO Secretary General Zurab Popolikashvili emphasized on more inclusive, resilient and sustainable tourism. Moroccan Minister of Tourism Fatima-Zahra Ammor also stressed upon responsible and inclusive continental approach to raise awareness of Africa's assets and improving Africa as a tourism destination. M Rakesh Kumar Verma, Additional Secretary, Ministry of Tourism also participated in the UNWTO Executive Council meeting and put up India's perspective on the subject.

The World Tourism Organization (UNWTO) elected Saudi Arabia as the chair of the Executive Council in Marrakech.

Saudi Arabia has now become the first Arab Gulf country to take charge of the chairmanship of the UNWTO's executive body. Saudi Minister of Tourism Ahmed Al-Khateeb, will represent the country

During the Conference, Morocco signed MOU for tourism promotion with Saudi Arabia. Several other bilateral agreements were also signed during the conference to boost tourism in different parts of the world.

Macro economic indicators:

The IMF expects growth of 1.25% in 2022

According to Consultation mission of services of the International Monetary Fund in Morocco, four elements are to be remembered at the end of their mission. The IMF team did not maintain the government's growth forecasts. Which expected 4% growth in 2023 (IMF: 3%); and 1.4% this year (IMF: 1.25%).

With regard to inflation, the Central Bank forecasts 2% in 2024. The IMF has said that such an objective would require further increases in key interest rates, in order to have effective inflation control.

Fitch confirms the BB+ rating for Morocco and anticipates a new monetary hardening

The global rating agency Fitch has retained the same rating for Morocco with BB+. The prospects are stable. Growth this year is expected to be 1.1% of GDP and average inflation to 6.2%. Fitch expects further increases in the key interest rate from Bank Al Maghrib.

Inflation Continues to Climb In Morocco Amid Rising Food, Energy Prices

Inflation in Morocco increased by an annual rate of 6.3% at the end of October 2022, according to a recent report from the Higher Commission for Planning (HCP), Morocco's state-owned economic intelligence center.

The high rise in inflation rates in Morocco is mainly attributed to the increase in food and energy prices. HCP data indicated that food prices jumped by an annual average rate of 10% at the end of October.

Meanwhile, despite dipping by 0.2% month-on-month, transport costs remain exceptionally high, with inflation averaging at 12% over the first 10 months of 2022.

France Tops List of Investment Destinations for Moroccans

France ranked as the top investment destination for Moroccans. During the first half of 2022, France received MAD 5.6 billion (\$523.6 million) from Moroccan investors.

The European country maintained its place at the top of the list of investment destinations for the second consecutive year. In 2021, France received MAD 8.4 billion (\$785.4) from Moroccan investors, according to data from Morocco's Exchange Office, the foreign trade's watchdog.

The Netherlands is the second most popular investment destination for Moroccans. At the end of the first half of 2022, the country saw an investment of MAD 530 million (\$49.5 million) from Moroccan investors, up from MAD 57 million (\$5.3 million) at the end of 2021.

Most of the investment has been in the manufacturing sector followed by the financial sector,

Morocco's Tourism Revenues Hit \$6.74 Billion in October

Morocco's tourism sector witnessed a sharp rebound in the third quarter of the current year and continued in the subsequent months as well, with recovery reaching to almost 85% of pre covid level. Morocco's revenues from tourism reached MAD 71.10 billion, or \$6.74 billion at the end of October, according to the data from the Foreign Exchange Office. The number represented an increase of MAD 42.37 billion (\$4 billion) compared to the same period in 2021. The data also exceeded the level reached at the end of October 2019 (MAD 67.02 billion or \$6.35 billion). The new statistics reflect the ongoing recovery of the tourism sector, which has been one of the most impacted industries due to the COVID-19 crisis.

UK Export Finance Invests £4bn to Boost Trade Ties with Morocco

The Department for International Trade (DIT) launched the "UK Export Finance" program in Morocco on November 23 at the British Embassy in Rabat. UK Export Finance (UKEF) will commit up to £4 billion (MAD 52 billion) to Moroccan buyers for projects in the region if at least "20% of the content is sourced from UK businesses."

Agriculture, the creative industries, and technology, as well as green hydrogen and green desalination are the main areas of interest for both British and Moroccan businesses.

Dependence on imports, main limits of the pharmaceutical industry (CESE)

In its 2021 annual report, the Economic, Social and Environmental Council (CESE) has highlighted on the self sufficient of the pharma sector in the Kingdom of Morocco

It has mentioned that "The Covid-19 pandemic has highlighted the strategic importance of the drug industry for a country like Morocco. Medicines, vaccines and various related products are not conventional goods, but rather strategic resources that should benefit from special treatment in public policies,"

Automotive industry: Stellantis will double the production capacity of its Kenitra plant

The "Stellantis" group, one of leading auto manufacturer has indicated that it will double the production capacity of its Kenitra factory. It aims to produce 450,000 cars per year. The project, estimated at a total cost of 300 million euros, will contribute to the creation of 2,000 new jobs.

Trade Minister: Morocco is Leading Exporter of Passenger Cars to Europe

Morocco's Industry and Trade Minister Mr Ryad Mezzour has stated that Morocco has strengthened its position to become a leading exporter of passenger cars to Europe, stressing that the North African country is overtaking China, Japan, South Korea, and the US.

The Minister made his remarks at the House of Councillors last month emphasizing Morocco's leadership role in the automotive industry.

Morocco is expecting automotive exports to reach MAD 100 billion (\$9.34 billion) this year, with a production capacity of 700,0000 cars. The North African country aims to have one million cars produced this year.

Neo: Morocco To Launch 100% Local Cars at \$15,000 Price

Morocco is set to launch a 100% Made in Morocco car brand "Neo" that would be available on the local market at an average price of MAD 170,000 (\$15,000), the country's Trade and Industry Minister, Ryad Mezzour said. After becoming the largest exporter of passenger vehicles to Europe, Morocco's car industry now looks to increase its share of the domestic market, as the industry ministry announced plans to launch budget-friendly cars under the label "Neo."

Companies

Belgium's SABCA Inaugurates Aeronautics' Assembly Plant Near Casablanca

Belgium aerospace group Societe Anonyme Belge de Constructions Aeronautiques (SABCA) inaugurated a new aerostructure assembly plant in Nouaceur in the Casablanca province.

The MAD 180 million (\$16.81 million) factory covers an area of 16,000 square meters creating approximately 240 jobs.

China's LONGi to Introduce "Hi-MO 6" Solar Cells to Moroccan Market

The world's largest solar module manufacturer LONGi is ready to introduce its new generation of solar cells "Hi-MO 6" to the Moroccan market, according to the statement released by the company. The Chinese manufacturer unveiled the new high-efficiency hybrid passivate back contact cell (HPBC) technology on November 2 in Egypt. The model, according to LONGi, achieves maximum efficiency of 22.8% in mass production.

OCP, Fertilizer and Phosphate news

Morocco's Phosphate and Derivative Exports Hit \$8.63 Billion in September

The value of Morocco's phosphate and derivative exports increased by nearly 67% at the end of September 2022, standing at MAD 91.8 billion (\$8.63 billion) compared to the same period last year, according to data from the Financial Studies and Forecasts Department (DEPF). The majority of the revenue has been earned by OCP.

DEPF attributed the development to the continued increase of phosphate and derivatives' selling prices. The numbers are in line with forecasts shared by finance and insurance company Fitch, which said that Moroccan-sourced phosphate rock is set to average \$270 per tonne at the end of 2022. DEPF also reported a decline in the volume of phosphate exports, explaining the decrease due to a drop in the volume of fertilizers by 10.5% and the volume of phosphoric acid by almost 34%. Fertilizer exports, meanwhile, increased by nearly 29% in volume and approximately 96% in value. Foreign sales of crude phosphate strengthened in value by an increase of around 63% against a drop in volume of nearly 43.7% at the end of September.

OCP Announces Launch of First Carbon Farming Partnership

Morocco's OCP Group has announced a partnership for an initial carbon farming and certification project across Mato Grosso, Brazil. OCP is partnering with farmers' cooperative Bioline by InVivo, agricultural tech company Agrorobotica, and Sementes Tropical to improve sustainable agriculture and carbon sequestration in soil.

The group stated that the project plans to cover areas of cotton, soybean, and corn, "which are representative of Brazilian agriculture," the group added. Through the partnership, the three partners aim to encourage degenerative farming practices to improve yield and soil quality through customized digital solutions tailored to the area and the crop
