### 3. Trade Promotional Activities organized in the month of August 2022

a- On 10th August 2022, Ambassador of India Mr. B.S. Mubarak along with Second Secretary (Consular) Mr. Anil Kumar visited the University of Medical Science and Technology, (UMST) in Khartoum. They were briefed on the University by the President of the University Dr. Hafiz Humeda and the Dean of various faculties

Ambassador briefly traced Sudan- India relations and made a presentation to the students on '75 Years of India's Development Story' to educate the students about India, its culture, educational system and technological advancements and how Sudan and India can share their experiences to foster academic cooperation.

b- As a part of 'Azadi Ka Amrit Mahotsav' to commemorate the 75 Years of India's Independence, Embassy of India, Khartoum in partnership with the Federal Ministry of Agriculture and the Council of International People's Friendship and the Union of Chambers of Agriculture, organized tree plantation drive on 13.08.2022 Saturday morning at the campus

of the Council of International People Friendship (Global Park), Khartoum. 75 Mango Trees were planted during the event. Hon'ble Minister of Agriculture H.E. Dr. Omer Abubaker Albushra was the Chief Guest. He planted the 75th Mango Tree at the event. Dr. Salwa ( Secretary General ), Dr. Amani (Asia Divison Head) and Dr. Hani from the Council of International People's Friendship and Mr. Munzir (Financial secretary) and Dr. Murtada (Secreatry General) from the Union of Chambers of Agriculture and Mr. Anwar the General Manager the National Forests Corporation participated at the event .At the inauguration of the event the Minister of Agriculture Dr. Albushra spoke about the strong links between India and Sudan. Ambassador Mubarak highlighted the significance of the 75th year of India's Independence and mentioned various initiatives taken by the Embassy of India to strengthen Economic Cultural and ties between the two countries.

c- As part of Embassy of India's outreach activity, Ambassador of India, Mr. B.S. Mubarak visited Allied Industries Co Ltd an Indian investment company in Al Gaily Industrial Area on 25 August 2022. CA Raghava officer in-charge of Allied Industries, Sudan operations organized a tour of the facilities.

Allied Industries uses advanced technology to manufacture four different kind of chemical products namely LABSA 96% (Sulfonic Acid), SLES 70% (Texapon), Sodium Silicate and Caustic lye. These chemicals are essential inputs in Soap and detergent industries, ceramic, and steel Industries. There are very few industries in Africa which manufacture these chemicals.

Ambassador also interacted with the Indian Engineers and Technicians working in Allied Industries.

Total Indian investments in Sudan up to December 2020 amounted to more than US\$ 471.5 million with 86 investment projects including 53 industrial projects, 21 service projects as well as 12 agricultural projects.(As per National Investment Authority of Sudan)

# 11. Status of ongoing major investments by Indian PSUs/Pvt. Sector in Sudan, and proposed Indian Investments in Sudan:

ONGC Videsh Ltd (OVL) invested over US\$ 2.3 billion in undivided Sudan. Currently there is an arbitration going on due to default in payment by the Sudanese side.

Despite the challenges that Sudan is experiencing in the National economic, investors from Gulf, Turkey, China, and India have already entered Sudan. Chambers and Partners have identified the following investment opportunities in Sudan:

- Natural resources/mining: especially gold.
- Agriculture: With the Nile River running through it, Sudan has more than 150 million hectares of arable land.
- Livestock: Sudan has national animal resources, which include cattle, camels, sheep, goats, poultry, horses, and an annual stock of more than 110,000 tonnes of fish. The most important animal products in Sudan are milk, meat, poultry, skins, fur and wool.
- Transport: As Africa's third-largest country and bordering seven countries, Sudan offers great opportunities for investment in the transport sector.
- Industry: Investment opportunities in industry in Sudan include following sub-sectors: agri-processing, food, spinning and textiles, leather, chemicals, pharmaceuticals, oil and soap, engineering, building materials and refractories, and printing and packaging.

### 21. Some Important Economic & commercial developments:

-on August 10th The Sudan Railways Corporation (SRC) celebrated the arrival of 21 new locomotives, which are the first batch out of (34) locomotives that will arrive successively from China, the manufacturing country.

The Railway Corporation organized a press conference at the Maritime Ports Corporation hall in Port Sudan, during which the Acting Minister of Transport, Eng. Hashem Abu Zaid, explained the importance of these locomotives in supporting the transport sector, indicating that this comes within the framework of an integrated plan to upgrade and develop various transport services including (land, sea, and air).

The Director-General of the SRC, Engineer Consultant Walid Mahmoud, explained efforts to raise the efficiency of performance in order to develop in the field of railway transport, pointing to the readiness of (1261) transport vehicles to meet the challenges of the ton transported via the railway, and support the state's efforts in the transfer of incoming and outgoing traffic Foreign trade, especially through seaports
